Fiber Procurement-Miscellaneous Features

- Conversion factors for converting from one unit of measure to another (tons to cords, cunits to tons, etc.) at tract level by product
- User-defined mileage rate tables containing miles and rates
- User-defined rate masters containing destination, producer, and owner rates along with effective date
- Methods of rate table payments include rate per unit of measure, rate per mile, flat amount per load, percent of destination gross, percent of truck gross, and rate per unit mile
